**RESOLUTION NO. 232 (2023) PARTIAL TAX EXEMPTION FOR REAL PROPERTY OF SENIOR CITIZENS**

WHEREAS, New York State Real Property Tax Law § 467 authorizes the Town, following a public hearing, to adopt a local law, ordinance, or resolution, providing that real property owned by one or more persons, each of whom is sixty-five years of age or over, or real property owned by husband and wife or by siblings, one of whom is sixty-five years of age or over, or real property owned by one or more persons, some of whom qualify under this section and the others of whom qualify under Real Property Tax Law § 459-c, shall be exempt from taxation by any municipal corporation in which located to the extent of fifty per centum of the assessed valuation thereof (the "Senior Citizens Exemption"); and

WHEREAS Real Property Tax Law § 467 further provides that the Town Board may amend any local law, ordinance, or resolution setting forth the Senior Citizens Exemption so as to increase the maximum income eligibility level to the extent provided in the schedule set forth therein; and

WHEREAS Macedon Town Code § 260-3 codifies Local Law 2-1996, whereby the Town Board adopted the Senior Citizens Exemption as prescribed in Real Property Tax Law § 467 and authorized the Town Board to adopt resolutions setting forth the terms and conditions of the exemption, including eligible income levels, as prescribed by statute; and

WHEREAS, following a public hearing on January 12, 2023, the Town Board adopted Resolution No. 36 (2023), setting forth the income eligibility schedule for the exemption, consistent with the schedule authorized by the latest amendments to Real Property Tax Law § 467; and

WHEREAS Real Property Tax Law § 467 further provides that the Town Board may direct that distributions from retirement accounts and annuities are to be included as "income" as defined therein; and now, therefore

BE IT RESOLVED, the Town Board hereby directs that distributions received from an individual retirement account or individual retirement annuity that were included in the applicant's federal adjusted gross income shall be considered income by the Town Assessor when addressing an application for the Senior Citizens Exemption; and

BE IT FURTHER RESOLVED, this resolution shall be effective immediately.
