RESOLUTION NO. 110 (2025) FIG HOLLOW AG VENUE SPECIAL USE PERMIT LEAD AGENCY AND SET PUBLIC HEARING

WHEREAS, Tricia Kuntz has applied to the Macedon Town Board to receive a Special Use Permit for an Agricultural Event Venue known as Fig Hollow;

BE IT RESOLVED as follows:

1. The Macedon Town Board makes the determination that the proposed action is subject to SEQRA, and is classified as "Unlisted" pursuant to SEQRA regulations,
2. The Town of Macedon is only involved agency, and a non-coordinated review will be performed,
3. The Town Board refers the SUP application to the Town Planning Board for their review and recommendation,
4. A public hearing will be held by the Town Board of the Town of Macedon, Wayne County, New York at 32 Main Street, Macedon, on April 24, 2025, at 7:15 pm for the purpose of hearing public comment on the application by Fig Hollow to operate an Agricultural Event Venue at 880 Yellow Mills Road in the Town of Macedon,

RESOLUTION NO. 111 (2025) AUTHORIZING THE ASSESSOR FOR THE TOWN OF MACEDON TO PERFORM AND UNDERTAKE A REVALUATION

WHEREAS, Section 305 of the NYS Real Property Tax Law mandates uniform and equitable assessments; and WHEREAS, computer-assisted mass-appraisal systems, technical advice, and financial assistance are available by cooperative agreement with the New York State Office of Real Property Tax and the Wayne County Real Property Tax Services Agency; and

WHEREAS, the last town-wide revaluation of real property was effective in 2022, and

WHEREAS, the Town Board believes that a revaluation is necessary at this time to comply with the aforementioned Section 305;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The Assessor of the Town of Macedon is hereby authorized to undertake and implement a townwide revaluation for the year 2026 assessment roll.
2. The Town Board does hereby agree to support the Town's assessment staff in this revaluation.
3. Any agreements resulting in a fiscal expenditure by the Town must first be authorized by the Town Board.
4. Any agreements with a private contractor to provide services for this revaluation must first be reviewed by the Town Attorney, the Assessor, and a representative from the Wayne County Office of Real Property Services.

WHEREAS, on February 23, 2023, the Town announced that it was sponsoring two recruits, Nash Ritz and Christopher Tyndall, to attend the Finger Lakes Law Enforcement Academy (the "Police Academy"), as confirmed by the Town Board's meeting minutes for the same date; and

WHEREAS, it has historically been the Town Board's custom and practice to hire police recruits upon sponsoring them for the Police Academy; and

WHEREAS, it was therefore the Town Board's intention to hire Officers Ritz and Tyndall on February 23, 2023; and

WHEREAS, Ritz and Tyndall successfully graduated from the Police Academy in October of 2023; and

WHEREAS, consistent with the Town Board's custom and practice, following their graduation from the Police Academy, Ritz and Tyndall immediately commenced their duties as Macedon Police Officers and have continued to do so to this day, with the full knowledge and approval of the Town Board; and

WHEREAS, the Town Board recently discovered that due to an administrative or organization error, the Town Board did not formally adopt a resolution on February 23, 2023 acknowledging that Officers Ritz and Tyndall had been hired as police officers, as was the Town Board's intent at the time; and now therefore,

BE IT RESOLVED, the Town Board hereby acknowledges and authorizes that Nash Ritz and Christopher Tyndall were hired as Macedon Police Officers as of February 23, 2023; and

BE IT FURTHER RESOLVED, Officers Ritz and Tyndall shall be entitled to all rights, benefits, and privileges available under the Macedon Police Department collective bargaining agreement subject to the aforesaid hiring date.
