#### Ontario-Wayne Stormwater Coalition

In accordance with the Federal Clean Water Act, which requires a phased approach to address water contamination caused by stormwater, New York instituted State Pollution Discharge Elimination System (SPDES) permits for construction activity, municipal stormwater discharges, and industrial activity stormwater discharges.

The Ontario-Wayne Stormwater Coalition was established to help municipalities comply with federal stormwater regulations and improve water quality in a cost-effective manner.

To maximize the efficiency and effectiveness of stormwater management efforts in Ontario and Wayne Counties, OWSC shares expertise, equipment, programming and funding to better fulfill the requirements of the New York State Pollution Discharge Elimination System (SPDES permit).

Any municipal entity required to comply with the SPDES system within the Coalition's area is eligible to join the Ontario-Wayne Stormwater Coalition to share in the benefits of established, successful programs and procedures.



## Which Municipalities Must Meet Stormwater Regulations?

Municipalities with stormwater discharge systems are designated as MS4s – Municipal Separate Storm Sewer System.

Storm "sewers" are any water-conveying structures, including road ditches, owned by the municipality. MS4s are classified and regulated according to size.

Phase 1	Large and medium-sized cities
Phase 2	Small MS4s, generally populations less than 100,000
Three Classifications of MS4s	
Traditional Land Use Control	City, Town or Village authority
Traditional Non-Land Use Control	Any County Agency without land use control
Non-Traditional	DOT, Thruway, County Highway Departments, Other State Agencies and Authorities, Airports, State and Community Colleges Federal: Post offices, VA hospitals, military bases, prisons
	Water, sewer and other special districts (schools, fire districts)

#### MS4 Operators Must Implement a Stormwater Management Plan Containing 6 Minimum Control Measures:

- Public Outreach and Education
- Public Participation and Involvement
- Illicit Discharge Detection and Elimination
- ◆ Construction Site Runoff
- Post-Construction Stormwater Management
- Pollution Prevention and Good Housekeeping: Utilization of Best Management Practices and Implementation of the program to the maximum extent possible.
